## 2011 Swimming Membership

**GENERAL INFORMATION:** Social Members are entitled to the privilege of use of the facilities of Brenham Country Club, except for golf facilities, subject to the by-laws, rules and regulations of the Club. Although Class "B" members have no equity interest in the property of the corporation and have no voting rights, they have use of the facilities and may serve on Committees of the Board of Directors. The Board of Directors of Brenham Country Club, Inc. approved the following procedures and regulations for implementing the offering of Social Membership in the Club:

- 1. Initiation Fee.** Applicants for Social Membership shall pay an initiation fee in the amount of **One Hundred Twenty Five Dollars (\$125.00)**.
- 2. Monthly Dues.** Social Members monthly dues are established by the Board of Directors are currently **Fifty Dollars (\$50.00) plus sales tax.**
- 3. Facilities Subject to Use.** Social Members are entitled to the use of all facilities of the Club except those facilities devoted to golf.
- 4. Limitation on Use of Golf Facilities.** Upon payment of fees in effect for public play and golf cart rental, Social Members may use the golf facilities of the Club on Tuesday, Wednesday, and Thursday as a public player and, on weekends, only as a guest of a Class "A" members, and at no time are private carts of Social Members authorized.
- 5. Modification of Procedures.** The Board of Directors may modify these procedures and regulations from time to time.
