Class B “Limited” Membership Contract

Contract Length: One (1) Year

General Information. Class B “Limited Members” are a non-proprietary and non-voting membership that shall have full entitlement to use of the club facilities while in good standing. Such Limited Members shall be subject to all standards for a Class B Membership, as provided by the By-Laws, and such Limited Members shall be subject to all other provisions of the By-Laws and Standing Rules.

1. **Term of Membership.** Limited Memberships shall be for **ONE YEAR** and may be renewed as approved by the Board of Directors.
2. **Initial Payment.** Limited Membership Applications must be accompanied by payment for **first and last months dues**.
3. **Monthly Dues.** Limited Membership **dues will be \$90 per month plus applicable sales taxes** billed on the 21st of each month. Your monthly statement which includes dues and any Club charges is due upon receipt of the monthly statement. Any members 30 (thirty) days past due will have their credit privileges suspended until they have paid the past due balance and brought their account to a current status.
4. **Cart Barns.** Cart Barns are available for an additional monthly charge on a first come first served basis.
5. **Trail Fee.** Members using their own carts who do not rent a cart stall will be billed \$20 per month trail fee.
6. **Club Carts.** Club Carts will be available for rental and cart usage is not included in the monthly dues.
7. **Approval.** All CONTRACTS shall be subject to final Board approval.
8. **Transfer to Class A Membership.** This membership can be upgraded to a Class “A” Membership by paying applicable treasury or transfer fees and upon Board approval of an application for transfer.
