Dear BCC Members,

This unseasonably wet and windy weather is cause for some soggy rounds of golf lately. In June, we had a tornado come thru and in July a hurricane. But not to worry, our course is greener and has more grass than ever before! Come play a round with us!

We have only one Tournament in the month of August. On August 3, the Fayetteville Baseball Alumni is holding their 2nd Annual Tournament with us. They have invited us to join in the fun with them on that Saturday morning if you can. Call the Pro Shop for more information.

The #16 green expansion is moving right along. We are expanding the back of the green by about 12 feet in order to allow for more pin placements. Sod was laid this past Tuesday, July 23rd and a temporary green will be used for a couple of weeks until the sod is stable. We will then rope off the new area and allow play on the original part of the green. Please respect the roped area and do not play on it until it is open.

I have had a large number of non-equity members participate in our Membership Transfer Drive to become an Equity Member. You can become an Equity Member for a total of \$75, if you make the move within the next 45 days. The \$375 transfer fee will be waived and we will apply our last month's prepaid dues you paid when you joined, towards the \$250 cost of the Equity Membership, leaving a remaining balance of \$75. CREDIT POLICY

Accounts 30 days past due will have their charging privileges suspended until their account is paid in full. Once the past due balance is paid, charging privileges will be re-extended.

Accounts 60 days past due will be posted and members will not be allowed to use any Club facilities until their account is paid in full. Once the past due balance is paid, charging privileges will be re-extended.

MEMBERSHIP TRANSFER DRIVE FOR ALL CLASS B NON-EQUITY MEMBERS

Become an Equity Member for a total of \$75, if you make the move within the next 45 days. The \$375 transfer fee will be waived and we will apply your last month's prepaid dues you paid when you joined towards the \$250 cost of the Equity Membership, leaving a remaining balance of \$75.
