Dear Members,

Happy New Year to all our members, friends and employees at the Brenham Country Club! We are looking forward to a healthy & successful new year. Our plans here at the BCC are to continue moving forward with continued improvement to the course, increase membership and golf play.

As the New Year begins, we will complete major repairs to our Pro Shop. In addition, the deck under the oak tree has become unstable and the tree has outgrown the deck. We will be leaving the scoreboard intact, but the wooden deck under the tree will be coming down for safety reasons. We will either rebuild the deck or put down gravel as it is under the other oak tree by the pro shop. This is still to be determined.

Our new hole marker signs have arrived and will be installed in the next couple of weeks, weather permitting. Jose and crew, along with Sterling Golf Management plan to continue to improve our course, with Mondays continuing to be our course maintenance day, allowing for larger projects to be performed such as chemical applications and work on greens, fairways, bunkers, tee boxes, etc. without interfering with play. We appreciate your cooperation on Mondays.

I would like to announce to everyone in advance **our annual dues increase will go into effect on February 1st**. In an effort to keep up with the cost of living the board agreed to a **4% dues increase** this year. Last year the board agreed to small annual dues increases instead of a sporadic larger increase every couple of years.
